## Notes on *Gift Aid*

***Gift Aid* COSTS YOU (THE PARENT) NOTHING. IT IS VERY VALUABLE FOR THE SCOUT GROUP.**

**You are urged to complete the *Gift Aid Declaration* on the Membership Subscription Form – there is nothing more for you to do, your committee will do the rest.**

The Inland Revenue introduced ***Gift Aid*** as a valuable and simple scheme to enable charities to re-claim tax on charitable donations such as subscriptions to Scout Groups.

The scheme has simple requirements:

- Donors must UK Income Tax and/or Capital Gains Tax.
- Donors must complete a simple “Gift Aid Declaration” form.
- The charity (in this case, Bere Regis Scout Group) re-claims the tax through the Inland Revenue.
- You must inform Bere Regis Scout Group Executive Committee should you cease to pay tax.

Please note the following.

- The Inland Revenue **repays to the charity** some tax you have already paid – **you** cannot reclaim this tax.
- Bere Regis Scout Group does **not** need to know how much tax you pay.
